MOBILE PHONE USAGE AT NETBALL REVOLUTION

This policy outlines the appropriate use of mobile phones and electronic devices whilst at Netball Revolution. For the purposes of this policy electronic devices include smart watches, I-Pads, laptops and any other electronic device. Mobile phones refer to any type of apple or android mobile device.

Netball Revolution recognises that personal communication through mobile technology is an important part of everyday life, however the use of these devices within our facility will be strictly controlled to ensure the safety of all.

RESPONSIBILITY FOR MOBILE PHONES OR ELECTRONIC DEVICES

It is the responsibility of athletes, parents / guardians who bring mobile phones or electronic devices to Netball Revolution to abide by the guidelines within this document. Any breach of these guidelines will be considered a breach of the Netball Revolution Code of Conduct.

LIABILITY FOR LOSS OR DAMAGE

Netball Revolution accepts no liability for the loss or damage of mobile phones or electronic equipment that is brought into our facility, nor for the replacement of any lost or damaged device. It is incumbent upon the athletes and parents / guardians to understand the capabilities of the device and the potential opportunities for loss or damage.

USE OF MOBILES PHONES OR ELECTRONIC DEVICES

- All mobile phones and electronic devices are brought to Netball Revolution at own risk.
- Mobile phone usage within Netball Revolution's training facility is to be in accordance with Netball Revolution's Code of Conduct.
- Coaches, employees, athletes and parents must request permission from all parties before photos or videos are taken.
- The use of a mobile phone or electronic device to harass, embarrass, bully or exclude another athlete at Netball Revolution will constitute a breach of Netball Revolution's Code of Conduct.
- Coaches, Employees, Athletes, and/or Parents / guardians using their mobile phone
 or electronic device whilst at Netball Revolution must ensure files stored on those
 phones or devices do not contain violent, degrading, racist or pornographic images.
 Transmission of such images is a criminal offernce. Similarly, sexting which is the
 personal sending of sexual imagery is also a criminal offence.

PERMISSION FOR NETBALL REVOLUTION TO FILM CONTENT

Netball Revolution includes permission to film athletes during drills or skills to be used for social media content or advertising purposes in all booking forms. No images or videos will be used of any athlete who does not wish to be featured (or whose parents do not wish for them to be featured). Coaches must confirm with the athlete / parent prior to filming.

BREACHES

Netball Revolution has the right to address any breach of this Mobile Phone and Electronic Device policy as a breach of the Code of Conduct. *This includes where a parent or athlete is not at Netball Revolution but the activity on the mobile phone or electronic device involves a coach / employee / athlete or parent/guardian of Netball Revolution.* Examples of this include such things as undertaking cyber – bullying or exclusion via mobile phone or electronic devices, or the sharing of images or personal information without permission.
